Article :**PEM LEHKHA LEH PEM KHAWM VENG***-Mangheta Ralte*

Editorial :

Tunlaiin kan ramah ruah tui a tla thain a tla tam tawh hle a, khel lova lo thleng thin chu leimin hi a ni. Fur a lo nih hi chuan lei a hmin tawh a, ruah bawhawk a han sur hi chuan lei a min duh hle a ni.

Kan veng hi kan awmna a awih hlawm avang hian leimin emaw lung lum emaw chungchangah hian kan fimkhur a ngai hle a ni. Kharel chhiatna a nih rual hian keimahni siam chawpah heng chhiatna hi thleng thei a nih avangin he veng chhunga chengte hi hemi kawngah hian kan harh thar a, kan fimkhur a pawimawh hle a ni.

Heng chhiatna hi a lo thlen thawh hnu hi chuan siamtha leh tur hi chuan sum leh tha tam tak sen a ngaih tawh thin avangin a hunlai hian kan harh a ngai a ni. Kan veng chhiat that thleng thei hi tute emaw rawn tih tur ni lovin, a chhunga cheng keimahni ngei hian tih a ngai a ni.

Tun tumah pawh hian kan vengah chuan local council-in disaster management committee a din ta reng a, veng dang pawhin an tih hma hauh a tih nachang an hria hi thil lawmawm tak a ni. Kan cho tihna ni lovin chhiatna lo thleng pawh nise kan ziaawm khawp ang.

Section YMA thutkhawm apiang maia Pem Lehkha chhiar tur a awm deuh ziah mai hian kan veng hi Pem Khawm Veng tia veng dang mite'n min lo fiam thin pawh hi a mawh love. A ni reng lah taka, kan veng hi veng naupang tak (Branch YMA, Kohhran leh Village Council indan atanga chhutin) kan ni a. Mizoram hmun hran hran atanga lutkhawmin tun dinhmun hi kan thleng a, Mizorama veng lian pawl tak kan lo ni ta reng mai.

He venga kan awm tantirha (*ala rei lo viau emaw tih laiin kum 20 alo ni ve ta reng mai*) kan chunga mi thenkhatte tawng dan, tun thlenga benga la cham reng mai chu, "Pem thar an nia, mi inhnuai luah lehngthal" tih hi a ni. Mahni a in leh lo nei ve ta lo chu, remchang apiang luahin kan insawn kual a tul a, mi inhnuai leh hnuai lote luah a tul thin reng a. Mi min sawi dan hi kan nihna chu a ni teh meuh mai. Mahse ngaihtuahna chu a titui duh khawp mai. Tun hnu ka chhut let hian, khatiang tawngkam chhakchhuaktute kha veng tana mi tangkai leh khawtlang hmangaihtu berte an lo ni lem lo, tun thleng pawh hian an ni ta chuang loin ka hria.

Chanmari West lo pian hma leh a pian hunlaia he venga lo awm tawh, mahni in leh lo hmun nghet nei, mi engemaw zat an awm ngei ang. Heng mite hian he veng hi intineitu hliah hliah bik pawh nise a awm tho e. Mahse, kan ti hram teh ang, veng thang lian zel tur chuan kan pem luhkhawm hi a ngai ve tlat.

Ti zawng hian kan ngaihtuah ve ngai em? Pem thar (*kan tawng tu'n lo how lo se*) leh la awm rei lo zawkte kan mitsir relh relh lai hian, veng mi hlun zawk nia inngaite hian khawtlang hmasawnnan eng chen nge tha leh zung kan sen ve le? Veng intineitu tako kan ruih thlek mai mai hian veng hmasawnna a thlen miah lo. Tawngkam ringawta "veng neitu leh veng hmangaihtu' nih hian awmzia a nei bawk lo. Veng hmangaihtu tak tak chuan, a awm rei tawh lam a ngaihtuah lova, mi inhnuai luah a nih lam thlir miah lovin, thahnemngai takin a thawk mai zawk thin.

A chunga kan sawi takte khi chu Mizo hnahthlak kara thil thleng thei chauh a ni. Hei aia pawi leh hlauhawm zawk chu – Mizoram pawn, chhim leh hmar, chhak leh thleng atanga rawn lutmek, kan ze anpui ni

miah lo leh, kan Hnam lam, Cheraw leh Khuallam te mawi min tihpui ve miah lotute hi an ni. Anni hi theihtawpa dan pawh tum ila kan dang seng dawn chuang lo tih chu a lang reng. YMA-in Pem Lehkha nen theih tawp a chhuah mek, a lawmawm thlawt, mahse kan inchiahpiah tual tual zel si chu a nih hi! Engtin nge kan tih tak ang le? Tuna veng chhunga Mizo Hnahthlak khawsa mekte hian, kan nundan leh chetzia hmangin, "Veng neitu leh veng hmangaihtu" kan nihna hi tilang ila, hnam dang unaute tana zahtlak turin, taimakna kawngah tan la thar ila, sual dona kawngah thahnem i ngai leh zual zawk ang u.

Khawvel ram zau zawk kan thlir chuan, Australia leh America (USA) ah te chuan a rama mi cheng hmasate chu Minorities an ni tawh tlat. Pem khawmin ram ropui an din a, a neitute an nek chhuak tawh a ni ber mai. Mahse heng ramte hi khawvela ram changkangte chu an va ni si ve? Chuti a nih chuan heng ramte hi kan entawn zawk dawn em ni? A tihci ve kher lo vang. Keini mikhualte hi chuan changkanna lam aiin sualna lamah min ti hmasawn zawk tlat. Heng kan mikhualte khawsak tamna veng, Aizawl chhuah lam leh tlak lam veng thenkhatte dinhmun chu sawi tam ngai lovin kan hriat theuh hi maw? Chuvangin, kan Ram, kan Hnam leh kan Veng hi tun atanga kan humhalh loh chuan reiloteah kan khawtlang leh Kohhran hruaitute hming hi keini ang lehkha thiam lo chuan kan chhiar thiam lo mai ang tihte pawh a hlauhawm rum rum alawm le.
